President Bryant reviewed an El Reno Tribune article highlighting Senior Nicholas Rinehart as being named Academic All-State.

President Bryant reviewed a "Thank-You" note from Wynnewood Public Schools.

President Bryant reviewed a "Thank-You" from Troy Milligan.

Dr. Kathleen Coughlan presented a power point presentation of their NASA Johnson Space Center trip that took place over spring break. RCC student Cooper Sadowsky is a NASA Intern who focuses on Public Relations. Cooper was also part of the Johnson Space Center trip. Cooper told the Regents about her experience.

Jena Marr updated the Regents on the recent Department of Education audit. She let the Board know it was a good audit. Two things will need to be changed this year. RCC will need to add an activity on Constitution Day and add some wording into the POISE system.

Jena Marr discussed a new 3 year, 0% interest, Dell Computer Lease Purchase with the Regents. This lease will start May 2016. Dr. Krittenbrink made a motion seconded by Dr. Carder to approve the Dell Computer Lease Purchase. Those voting for the motion: Regents Kitch, Ruhl, Dr. Carder, Dr. Krittenbrink, and Thompson. Jena Marr discussed refinancing of the 2006B Master Lease Real Property Project. This refinance will save the college just under \$14,000. Regent Kitch made a motion seconded by Dr. Carder to approve the refinance. Those voting for the motion: Regents Kitch, Ruhl, Dr. Carder, Dr. Krittenbrink, and Thompson. President Bryant updated the Regents on the PTK UCO Pipline Proposal Agreement. Dr. Smallwood and President Bryant have been working the last few months to establish a series of new transfer scholarships for Phi Theta Kappa. UCO has now assigned \$10,000 a year for RCC for PTK Transfer Scholarships \$500 per semester. RCC selects the students from their PTK members.

Reonna Slagell-Gossen updated the Regents on the Soil Health and Cover Crop Conference. Gabe Brown from Bismarck North Dakota spoke about his no-till cropping systems. Ray Archuleta, USDA Soil Scientist, spoke about Biomimicry Strategies and Agroecology principles. WE had 109 participants at this conference. Many of them were producers.

President Bryant updated the Regents on the discontinuation of the Center for Transportation Safety partnership. As of April 30, 2016 RCC will no longer have CTS on the campus.

President Bryant discussed the draft policy 428: Faculty Senate. This would move RCC away from Faculty Association to a Faculty Senate. It would no longer be a dues paying organization. It would be open to any faculty member full or part time. The Board asked that the committee provide their by-laws at the next meeting. This item was tabled.

President Bryant updated the Board on the dissolution of RCC's partnership with El Reno Public School in the area of Science instruction. Superintendent McVay said in his letter this dissolution was in no way a reflection of the job performance of Professor Brenda Witt. It was solely due to severe budget restrictions.

President Bryant asked to table item 14 discussion and vote to approve/disapprove appraisal of Jones Road Property.

President Bryant asked to table item 15 discussion and vote to approve/disapprove scheduling and auction for the Jones Road Property.
